## **Building Permit Fee Schedule & Information**

## **Charter Township of Madison**

Charter Township of Madison issues Building, Electrical, Mechanical and Plumbing permits. Applications are available Online or in the office. If work for which a permit is issued is not started within six (6) months of the date of the permit issued, or if the work is stopped or abandoned for a period of six (6) months, the permit may lapse and cease to be in effect. When no inspection has been requested during the six (6) month period, the Township shall cause the premise to be inspected to ascertain the status. The permittee will be assessed a sixty five (\$65)dollar inspection fee to reimburse the cost of such status inspection. In the event the permit lapses, any unexpected amounts of the permit fee shall be used to defray expenses of processing and maintaining the Township's file on on the matter. After permit has lapsed, no further construction shall take place until a new permit for the remaining work has been issued in accordance to the Township fee schedule, or an extension granted.

## \* A CERTIFICATE OF OCCUPANCY MUST BE ISSUED PRIOP TO MOVING INTO PERMITTED AREA \*AGRICULTURAL BUILDINGS MUST ONLY BE UTILIZED FOR AGRICULTURAL ANIMALS, PRODUCTS OR IMPLEMENTS AND REQUIRES A LETTER/AFFIDAVIT STATING ONLY AGRICULTURAL USE \* PERMIT FEES ARE BASED ON \$65 PER INSPECTION. ADDITIONAL INSPECTIONS WILL BE CHARGED OVER AND ABOVE THE INITIAL PERMIT FEE.
